COOPERATION AGREEMENT

between

WISSENSCHAFTEN FÜRTH)**
Germany

It is the desire of the parties named herein that a Cooperation Agreement be formalised based on the headings set out below:

1. Parties to the Understanding

- 1.1 Romanian-German University, 2400 Sibiu/Hermannstadt, Romania, represented by the Rector, hereinafter referred to as "Ro-Ger"
- 1.2. Wilhelm Löhe University for Applied Science, Merkurstraße 41, 90763 Fürth, Germany, represented by the President, hereinafter referred to as „WLH".

2. Statement of Purpose

- 2.1 Ro-Ger and WLH recognise common interests in common, especially in the fields of management in health and social care, and that there will be mutual benefits from collaboration and co-operation. Especially, the both parties are aware that the European Idea is based upon ethical and cultural values rooted in Christian tradition.
- 2.2 The partners wish to formalise and standardise the ongoing relationship between both parties in order to provide consistency. Moreover, it is aimed to establish an organised form of cooperation and administration of different programmes for academic cooperation and collaboration.

5. Disclaimer

- 5.1 Nothing will diminish the full autonomy of either party, nor will any constraints or financial obligations be imposed by either party upon the other in carrying out this Agreement.
- 5.2 The parties agree that this Cooperation Agreement will only act as a basic cooperation strategy. Every point of common interest requires a detailed cooperation between both parties, especially regarding to responsibilities and financial resources.

6. NOTWITHSTANDING the signatories herein, the final acceptance of this Memorandum is subject to ratification by the Governing Bodies of the Parties.




